### *Reading - RI and Acadience fall data*

Fall Acadience k-3<sup>rd</sup> = 73%; 75% last year – target shifts each assessment leading students to end-of-year proficiency level

Fall RI 4<sup>th</sup> and 5<sup>th</sup> = 58%; 40% last year – target does not shift, the fall target is the end of year target

### *Math Acadience fall data*

k-5<sup>th</sup> = 40%; 61% last year

### *Land Trust/TSSP review, school focus*

Main focus will continue to be English Language Arts and structured classroom discussions, also pulled in dyad reading. There are some barriers to use because some of the strategies are face-to-face and shoulder-to-shoulder, COVID precludes close contact between students.

In February, the plan was to increase SW and School Psychologists to full time and behavior assistant to Fridays. There is not a psychologist to be hired at this time. School will not be held on Fridays making the additional hours for behavior assistant unnecessary. Software – Reading Plus for upper grades, and Dreambox for math were primarily funded by state grants. Some of the funding is going to Chromebooks and getting us 1-to-1.

#### *Discussion - What are the needs of the teachers?*

May be unhelpful for teachers to get more software. Teachers are getting training on Dreambox and other tools to transition to virtual in sustainable ways.

Canvas training may be helpful. Trouble shooting tech for parents is a needed. May need a para-professional or other tech support. Parents who are doing on-line have used forms and talked to the district, as well. May want to use the funding for 95% Group intervention (explicit phonics intervention).

#### *Digital Citizenship Week is postponed.*

May adjust to more frequent ongoing activities rather than a one-week focus. (We already are doing this, but the state is promoting a week event.) Mrs. Guzman (formerly Bond) is our new coordinator.

#### *School happenings*

**COVID precautions** – mask wearing is going ok, kids are doing great. Have limited student co-mingling across classrooms. Most students wear masks outside even though masks are not required outside. Current plans for Halloween Party will include 3 volunteers. But, if numbers increase this plan may change. Are seeing quarantining happening due to older siblings and parents, currently have less than 5 students who are COVID positive.

**Emergency Drills** – continuing these requirements, but they look a bit different with the COVID precautions.

**Friday change** – this week is the first Friday that is 100% virtual – teachers are ready. Principal

**Faculty and Staff positions** – fully hired for all positions, started with a long-term sub
