Silver Mesa Elementary School Community Council was allocated \$78,300 of LAND Trust funds for the 2019 - 20 school year.

Silver Mesa Elementary School Community Council determined that funds should be spent on reading, math, and technology. To increase reading and math achievement, students were identified as performing below benchmark on Acadience or Reading Inventory testing. Students identified received intervention support. Most of the allocated School Land Trust funding, \$28,000, was used to hire four assistants to provide reading interventions and two assistants to provide math interventions. A total of \$1,700 was spent on substitutes, and \$3,400 for stipends and registration costs to provide teachers additional professional development. Lexia and DreamBox, literacy and math online programs, costing \$12,400, were purchased to be in used in skill-based instruction and literacy practice stations. Chromebooks and iPads cost \$23,500. Silver Mesa is 1:1 with iPads and Chromebooks across grades 1-5 and 2:1 in kindergarten. The Silver Mesa SCC sees our LAND Trust Plan resources as a crucial component of our student achievement. It also helps that Silver Mesa teachers are simply the BEST!

ENGLISH LANGUAGE ARTS

 By May of 2020, 83% of students in K-5 will demonstrate mastery of core standards in English Language Arts as measured by the Acadience assessment (k-3) and the RI assessment (4-5). In winter of 2020, 77.79% of students met reading benchmarks.

MATHEMATICS

 By May of 2021, 80% of students in K-5 will demonstrate mastery of core standards in Math as measured by the DIBELSnet assessments. In winter of 2019, 75% of students in K-5 were proficient in Acadience math assessments.
